### **PARAMEDIC**



Paramedics are allied health professionals whose primary focus is to provide advanced emergency medical care for critical and emergent patients who access the emergency medical system (EMS). Acting as a link from the scene to the healthcare system, paramedics function as part of the comprehensive EMS response, under medical oversight. Garrett College's paramedic program is nationally accredited by the Commission on Accreditation of Allied Health Education Programs (www.caahep.org) upon the recommendation of the Committee on Accreditation of Educational Programs for the Emergency Medical Services Professions (CoAEMSP).

### **PARAMEDIC**

Continuing Education & Workforce Development offers the initial paramedic training program in person every two years and on an accelerated/hybrid schedule yearly. Successfully admitted students have the opportunity of also selecting one of the three educational options at Garrett College: a credit Certificate (30 Credit Hours), and Associate of Applied Science, A.A.S. (60 Credit Hours) degree, or a non-credit certification program.



#### **ENTRY REQUIREMENTS:**

- Students are required to have a High School Diploma or equivalent.
- Students must be currently certified as an EMT.
- · Students must complete entrance testing which evaluates math, reading and basic

### **VETERINARY ASSISTANT**



Veterinary Assistants aide in kennel care, assist veterinary technicians and veterinarians during exams of domestic animals and provide support throughout the veterinary office. They are employed in animal shelters, animal emergency centers, and veterinary practices. This training program meets the National Association of Veterinary Technicians of America (NAVTA) guidelines and requirements for clinical experiences, certifications/licensing of instructors, and curriculum content. Upon successful completion, students will be prepared to work in an entry level position in an animal care facility and/or be prepared to continue training to earn an AA degree as a Veterinary Technician. # **ED2GO: ONLINE OFFERINGS**


PHARMACY TECHNICIAN: Pharmacy technicians assist and support licensed pharmacists in providing healthcare to patients. The Pharmacy Technician Online Certification Training Course was developed in response to a rising need for trained technicians to work in hospitals or retail pharmacies. However, this growing opportunity has also come with increased responsibility, making certification an essential issue for many industry employers and some state legislatures. Some states now require all individuals who work as pharmacy technicians to become nationally certified. This course will prepare you for entry-level pharmacy technician positions by teaching you medical and pharmaceutical terminology, basic anatomy related to the pharmacology of medications, and pharmaceutical calculations. Upon completion of this course, you will be prepared to sit for the Pharmacy Technician Certification Exam (PTCE) offered by the



Pharmacy Technician Certification Board (PTCB). This course also includes a voucher which covers the fee for the exam. However, you must ensure that the Pharmacy Technician Course meets your state's requirements. For more information, visit your state's Board of Pharmacy site directly from the Pharmacy Technician Certification Board (PTCB) website.

**CERTIFIED EKG TECHNICIAN:** Electrocardiography (EKG) technicians are vital members of any healthcare team. Provide a copy of your high school diploma or transcript.

Students must submit a non-refundable \$25.00 registration fee.

You will be contacted by the Program Coordinator to schedule an Orientation Session and a time to take the TABE (Tests of Adult Basic Education) if required for the training program. The TABE is used to insure students have the basic math and reading skills required to successfully complete their chosen training program. Remedial assistance may be available to improve math and reading skills.

#### **REQUESTS FOR 504 ACCOMMODATIONS**

Garrett College is committed to the success of its students and provides resources to support student learning, including accommodations. There are significant differences in how students obtain accommodations in college as compared to high school. Academic accommodations are not automatic and students should be self-advocates when requesting services. Students who wish to obtain accommodations for their classes must follow Disability Support Services (DSS) procedures:

#### 1. COMPLETE THE APPLICATION FOR 504/ADA ACCOMMODATIONS.

# 3. STUDENTS WILL BE REQUIRED TO PROVIDE CURRENT (WITHIN THE PAST THREE YEARS), WRITTEN PROFESSIONAL DOCUMENTATION IN ORDER TO VERIFY ELIGIBILITY FOR SPECIAL

**SERVICES.** Such documentation can be in the form of medical reports or psychological evaluations, and must specify how learning is impacted including specific accommodations to assist in the learning process.

Please note, you are not considered fully registered with the office until you have been approved for accommodations. Records provided are kept strictly confidential, and information provided is shared only with permission provided by the student.

### **GENERAL ENTRY REQUIREMENTS**

- A \$25.00 non-refundable application fee is required from all students.
- Students are required to have and provide a copy of their High School Diploma, Transcript or equivalent unless concurrently enrolled in an ABE/GED program.
  - Students are required to take the TABE Assessment prior to enrollment.
    - Students must participate in an Orientation and Information Session.
  - Students must maintain a 75% average in each class and meet attendance requirements to progress to the next course of the program.

#### REGISTRATION INFORMATION

Registration for non-credit courses can be completed in person, by phone, by mail, by fax, or online. Persons interested in registering for a course may visit the office, located in room 114 of the Garrett Information Enterprise Center on the McHenry campus of Garrett College. They may also call the main line at (301) 387-3069, or fax a registration form to (301) 387-3096. To register online, visit www.garrettcollege.edu/cewd.

Continuing Education & Workforce Development registrations will be taken on a first-come, first-served basis. Your birth date is required by the Maryland Higher Education Commission. Payment may be made by mail or in person at our office. We accept VISA, MasterCard, American Express and Discover - please call us at 301-387-3069.

Most courses have registration deadlines, which allows for ample time to notify students and instructors, should a course not meet its minimum enrollment. The department recognizes the inconvenience last-minute cancellations cause in the busy lives of our community members. Please register before the deadlines.

#### FINANCIAL INFORMATION

Course costs listed include tuition, fees, and out-of-county/out-of-state differentials (where applicable). Costs listed for Maryland Senior Citizens (persons 60 years of age or older) include a tuition waiver (where applicable) and fees. All students are responsible for any materials or texts that may be required for all classes.

#### **REFUND POLICY**

Submission of a registration form and tuition and/or fee payment serves as confirmation of registration and results in the student being obligated for the cost of the course. If, for any reason, a student cannot attend the course for which they registered, it is their responsibility to withdraw from the course by calling 301-387-3069 or emailing the Program Coordinator directly. Refunds will be made in full if the student withdraws from a course prior to the registration deadline or closing date. If a student withdraws prior to the second class meeting, they may be eligible for a partial refund, but it is not guaranteed for all courses. There will be no refund after the second class session.

Any requests for exemption to this policy must be made in writing and should be submitted to the Dean of Continuing Education & Workforce Development.

### FINANCIAL AID

# Available to those who qualify

Garrett College's Continuing Education & Workforce Development division awards over \$100,000 in scholarships annually as a result of funding from Garrett County Commissioners, local agencies, and private donors through the Garrett College Foundation. Full and partial scholarships are available based on the applicant's residency, educational goals and financial need. For best consideration, students are encouraged to apply early! Scholarship applications must be submitted at least three weeks prior to the start of selected program for consideration.

All workforce programs require a \$25 non-refundable application fee which cannot be paid with scholarship funds. The student is also responsible for any program fees, tests, or materials which are not covered by his/her scholarship.

#### **Drop Policy**

It is the student's responsibility to withdraw from a course that he/she cannot attend. Please note that failure to attend at least 75% of the course sessions, or failure to complete assigned coursework, may result in the termination of funding; as a result, the student will be charged for the entire cost of the course.





#### INCLEMENT WEATHER POLICY

#### WHEN ARE WEATHER-RELATED DECISIONS MADE?

Because weather and road conditions can change quickly, there is no fixed time by which a decision to delay or close is made.
