Advanced Portrait Painting PI-147

NEW! Digital Photography - You & Your Camera Pl-687

In this course, you will explore the basic camera controls, such as exposure, selective focus, aperture settings and fundamentals of composition. Through lectures, demonstrations and hands-on lab sessions students will become adept at making and understanding digital images. Working with your digital camera, you will complete a number of assignments that emphasize camera controls, composition and subject matter. Class lectures and demonstrations will show the basics of exposure, quality of light, depth of field, and discussion of file formats, resolution requirements and file compression. A brief history of photography will be covered to have an understanding of how we got to where we are in the digital image world today. The class will also be exposed to works of historical photographers. Please note: This is not a class for Point-and-Shoot cameras. Students will need to bring or provide their own Digital Single Lens Reflex (DSLR) camera for discussion purposes, along with the operating manual for reference.

Feed bags are made of incredibly sturdy material and come in all sorts of pretty colors and patterns. Tap into your creative side and learn the steps to turn a feed bag into a sturdy and useful tote for groceries, the beach, books or kids overnight bag - almost anything you can think of. It is ideal for gift giving and is an inexpensive, easy, eco-friendly way to help save the environment. Bring your own (clean) feed bag (woven plastic bird seed, chicken feed or similar) and one yard of cotton fabric (be creative!) to line the bag along with a cutting mat, large cutting ruler, rotary cutter, scissors, pin cushion, upholstery thread, heavy duty sewing needle (denim/jeans) and sewing machine. What links all these forms is that the "I," the literary version of the author, is either explicitly or implicitly present—the author is in the work. In addition to the craft of writing, we will also focus on issues of researching magazine markets, and writing effective query letters. Students should be prepared to write weekly assignments, read them in class and participate in critiquing the work of others.

Rick Sivic Sr., Boston Hill Training, is certified by the Utah Bureau of Criminal Identification (BCI), a Maryland State Police Qualified Handgun Instructor and an NRA certified firearms instructor.

MD Hand Gun Qualification (HQL) PD-823

This Handgun Qualification License training includes classroom instruction on state firearm law, home firearm safety, handgun mechanisms and operation, and a component that requires the applicant demonstrate the ability to safely fire a handgun. Unless otherwise exempt, as of October 1, 2013, a Maryland Resident must possess a valid Handgun Qualification License before they may purchase, rent, or receive a handgun. Fingerprinting is required to obtain a handgun license and is not included in the price of the class. (It may be offered during the class depending on the number of students.) Approved HQL training courses are offered by Maryland State Police approved Qualified Handgun Instructors. Training is valid for three years and must be completed prior to submitting an application for a Handgun Qualification License. You do not need a Handgun Qualification License to own a gun you already have. Students must be at least 18 years but cannot obtain a handgun license until they are 21 years of age. No one is permitted to bring a weapon or ammunition to class.

Utah Concealed Firearms Permit Training PI-558

If you travel throughout the United States and wish to carry a concealed handgun, this class qualifies to get your conceal carry permit through a one-day training. After completing this course, you will be eligible to apply for a Non-Resident Utah Concealed Firearm Permit which is honored in 31 states. It does NOT include Maryland or Pennsylvania.

This 5 hour class covers all aspects and requirements required by the state of Utah. You must also pass a criminal background check in order to obtain a permit. Utah application will be completed during the class and reviewed for completion. Photographs and fingerprinting will be done during the class. Please note- if your home state issues a concealed carry permit, you need to provide a copy of that permit to obtain your Utah permit. This does not apply to MD residents unless you currently have a permit. Class charges include fingerprinting, photography service & providing you with packet to mail.

NOT included in the class fee is a \$67 Permit fee to the State of Utah (either by credit card or check). Permit is valid for 5 years.

This will include a detailed discussion of the legal documents all persons should have including a will, power of attorney, and advance directive. Mrs. Shaw earned a BA in vocal performance and a BA degree in music education from Alderson Broaddus University. She is classically trained, coloratura soprano, but frequently performs songs in the genres of musical theatre, pop/rock and jazz for weddings and music venues. She is an accomplished pianist and also plays a variety of woodwind instruments. Before moving to Garrett County, Shaw was employed as a music teacher in Anne Arundel

County Public Schools for eight years. She also had a private studio in which she taught voice and piano lessons. As a performer, Shaw was selected as the soloist with the Baltimore Choral Arts Society and accompanying orchestra. She is currently a freelance performer for weddings and special events. Additionally she sings on the praise team at Crossroads Church in Oakland.

Voice Lessons PD-899

This course is designed for individual studies in the training of vocal activities related to singing, for all ability levels. Beginning students will learn correct posture and breathing, tone production, diction, sight singing, notation reading, ear training and general principles of vocalizing. 

CERTIFIED NURSING ASSISTANT (CNA)

State of Maryland regulations require that anyone who performs nursing tasks, delegated by a nurse for compensation, must complete an approved Certified Nursing Assistant (CNA) course of study and be certified by the Maryland Board of Nursing. The following two classes prepare you for your CNA certification. Those individuals who desire work in long-term care facilities (nursing homes) must, after completing the CNA course, also take the Maryland NNAAP registry test (written and skills) to become certified as a Geriatric Nursing Assistant (GNA). Additional fees apply for this test and are not included in the CNA tuition.

MEDICAL BILLING and CODING

The medical billing and coding profession is one of the fastest-growing careers in the healthcare industry today! The need for professionals who understand how to code healthcare services and procedures for third-party insurance reimbursement is growing substantially. Physician practices, hospitals, pharmacies, long-term care facilities, chiropractic practices, physical therapy practices, and other healthcare providers all depend on medical billing and coding for insurance carrier reimbursement. The medical industry will have almost 50% more jobs available by 2018; therefore, a surplus of medical facilities will continue to hire candidates who specialize in medical billing and coding.

ABOUT THE PROGRAM:

This billing and coding program delivers the skills students need to solve insurance billing and coding problems. It details proper assignment of codes and the process to file claims for reimbursement. With the transition to ICD-10, effective as of October 1, 2015, this course will also provide training in ICD-10-CM. This course covers the following key areas and topics:

- An overview of healthcare and insurance industry

PARAMEDIC

Paramedics are allied health professionals whose primary focus is to provide advanced emergency medical care for critical and emergent patients who access the emergency medical system (EMS). Acting as a link from the scene to the healthcare system, paramedics function as part of the comprehensive EMS response, under medical oversight.

Garrett College's paramedic program is nationally accredited by the Commission on Accreditation of Allied Health Education Programs upon the recommendation of the Committee on Accreditation of Educational Programs for the Emergency Medical Services Professions. Continuing Education & Workforce Development offers the initial paramedic training program on a two-year cycle.

PROGRAM GOALS:

- Prepares competent entry-level Paramedics in the cognitive (knowledge), psychomotor (skills), and affective (behavior) learning domains, with an exit point at the Maryland CRTI level.
- After the first year and upon passing the NREMT I'99 exam, individuals will be eligible to sit for the Maryland Cardiac Rescue Technician (CRTI) exam to obtain state certification.
- After completing the second year of the program, students will be prepared to take the national and state certification tests to obtain their National Registered Paramedic (NRP) and Maryland Paramedic certifications.

TIME to COMPLETE PROGRAM:







COMMERCIAL DRIVER'S LICENSE (CDL), Class B

With a Class B CDL, students can drive cement, gravel, delivery, and refuse trucks allowing them to make a good salary, but also stay close to home.

This course will cover the essentials needed to obtain a Class B license including the following: pre-trip inspection, various skills in the yard, and over-the-road instruction along with a basic overview of map reading and log books. At the completion of training, the student will demonstrate at their local Department of Motor Vehicles to



obtain a Class B license. To expand, the Class B license allows an individual to operate any single vehicle with a gross vehicle weight rating (GVWR) of 26,001 or more pounds; with any such vehicle towing a vehicle not in excess of 10,000 pounds GVWR.

Garrett College's Continuing Education & Workforce Development division awards over \$100,000 in scholarships annually as a result of funding from Garrett County Commissioners, local agencies, and private donors through the Garrett College Foundation. 



INCLEMENT WEATHER POLICY

Continuing Education and Workforce Development follows the Garrett College Inclement Weather Policy.

WHEN ARE WEATHER-RELATED DECISIONS MADE?

Because weather and road conditions can change quickly, there is no fixed time by which a decision to delay or close is made. While we attempt to make decisions for all-day closings and delayed openings by 6:30 AM, you should always consider the possibility that the decision may come after that time. Decisions to close early are made based upon information about the conditions, which means that there is no set time that these decisions will be made either; however, the College attempts to have a decision made about closing early by 3:00 PM.

HOW DO I FIND OUT IF THERE IS A DELAY OR CLOSING FOR THE COLLEGE?

The College's weather-line is immediately updated with any information that relates to the altering of the normal schedule.

HOW DO I KNOW WHICH LOCATION IS CLOSED?

Announcements made that the College is closed due to weather conditions include all locations: McHenry campus, Northern Outreach Center (Grantsville), Career and Technical Training Center (Accident), and the Southern Outreach Center (Oakland). There may be times when a particular location is delayed or closed for reasons other than weather. The information that is disseminated at that time will specify which location(s) are affected.

Employees, students and the public should not call any college department to find out whether the college is closed or is going to close. We ask that you call the weather-line for closing or delayed opening information. Note: The College will not make an announcement if operating on a regular schedule. If no information has been posted, then the College will be operating as normal.
