Up to five \$500 scholarships will be awarded.

Qualifications:

You must

- Be a woman at least 2 years past a high school degree or a high school equivalency (GED);
- Be at least 20 years of age;
- Be accepted to an accredited vocational, technical, or academic program at an accredited institution, which will lead to a certificate of completion or degree, and;
- Have lived, worked or attended school in Garrett County for at least the past 5 years.

To apply, you must:

1. Complete an application;
2. Provide a transcript if already attending;
3. Provide proof of enrollment in an accredited vocational, technical, or post-secondary school, college or university; and
4. Get one letter of reference.

Deadline: May 14, 2021 @ 4:30 p.m.
