

Student Right-to-Know Act Graduation and Transfer Rate Report

In accordance with the Higher Education Act of 1965, as amended, Garrett College is pleased to share with you the following information on the graduation and transfer-out rates of our Fall 2017 cohort of full-time, first-time, degree or certificate seeking undergraduates and student athletes that received athletic financial aid.

Fall 2020 cohort was used for:

- The number of students, categorized by race and gender, who attended the school in the year prior to the submission of the report.
- The number of the students above who received athletically related student aid, categorized by race and gender within each sport.

While reviewing this information, please keep the following in mind for the Fall 2017 cohort:

- All graduation rates are based upon 3 years of attendance which equates to 150% of the normal completion time of our longest program.
- These charts do not identify the reasons why our students withdrew; therefore, students who withdrew for personal or medical reasons are included.
- Graduation and transfer-out rates do not include students who left school to serve in the armed forces or on official church missions or with a foreign aid service of the federal government, or students who died or were totally and permanently disabled.
- An asterisk (*) denotes any cohort/subcohort with five or fewer students. The college is not required to disclose this information.
