#### **Purpose & Scope:**

The purpose of this bid is for procuring an adequate supply of propane for Garrett College and the Garrett County government's use at the best competitive firm and fixed price for the 2019 fiscal year beginning July 1<sup>st</sup> 2018. Accordingly, bidders are being asked to submit bids at this time for the following scope:

• Fixed pricing for approximately 171,500 gallons of propane for delivery during fiscal year 2019
